#### Administrative Issues

# Directors Compensation

Upon the motion of Randy Tyler, seconded by Mike McCabe Resolution 2021-3 fixing director compensation was unanimously passed.

Mayor of Lawrenceburg, Kelly Mollaun, was present to discuss the lease agreement between the City of Lawrenceburg and the LCD. He requested that the LCD reach out to the City of Greendale and Dearborn County for funds to pay for any work and maintenance done to the Greendale levee.

Year-end accounting overview reports from Reedy Financial Group were reviewed and discussed.

#### Superintendent's Report – Lawrenceburg Levee

Superintendent Paul Seymour reported on various matters.

John Mundell continuing to work on ponding area analysis and other related projects.

Station #3 project is ongoing. Received comments from USACE, so working through that.

Hrezo Engineering working on putting together bid documents for the discharge project. Hope to have it awarded by dry season.

SCADA project is ongoing and will hopefully be complete within the month.

Third party review of the Whiskey River Apartments is going well.

USACE levee safety meeting was held at LCD on 1/21 from 3-5pm.

SWS is working on collector system video.

Paul met with City of Lawrenceburg Mayor, Kelly Mollaun, to discuss FEMA accreditation. Will continue to keep him updated.

The survey of the Scudder property has been recorded. Attorney, Jared Ewbank, is drawing up a final purchase agreement between LCD and Bruce Lagory.

Paul requested to get quotes to order more LCD books.

#### Superintendent's Report – Greendale Levee

Kendall Bales with Johnson, Miriam & Thompson was present to share an update on the Greendale levee certification work. He is continuing to collect past reports and history. Bales presented two potential task orders — one for an interior drainage analysis and one for an aerial survey. Upon the motion of Mike McCabe, seconded by Randy Tyler, it was unanimously approved to move ahead with the aerial survey. The interior drainage analysis will be tabled until the directors see a task order proposal for the geo tech portion of the project.

Paul continuing to meet with City of Greendale officials to educate them on FEMA accreditation process and more.

# **Secretary Report**

Secretary Chelsie Noel reported on various matters.

City of Lawrenceburg lease agreement check was received and had been appropriately increased per the agreement in place.

Property insurance policy with Selective Insurance has been renewed, per the vote last month.

#### Finance Committee Report

Jim Kittle gave an update on Reedy Financial Group billing for 2020.

Conversation was had regarding the contract renewal for Reedy Financial Group.

Jim Kittle will present the City of Lawrenceburg lease agreement financials for 2020 to the mayor in the next few weeks.

Superintendent Compensation

Upon the motion of Jim Kittle, seconded by Al Abdon, Resolution 2021-5 fixing secretary compensation at \$20.57/hour was unanimously approved. Mike Noel abstained from voting.
