#### **Administrative Issues**

The meeting was called to order by Chairman Mike Noel.

The Directors (and others) recited the Pledge of Allegiance.

#### **New Business**

Attorney, Jared Ewbank, stated that additional ballots for the 2023 LCD election were discovered at the post office. Ewbank gave a rundown of the events that led up to this finding and shared that the ballots had been put in an overflow box instead of the District's PO Box, unbeknownst to Ewbank and secretary, Chelsie Noel, who had been in charge of retrieving ballots. Ewbank was unclear on exactly how many ballots were discovered in the overflow box and explained that he had not yet retrieved the ballots, as he wants to follow the routine procedures and go with Chelsie.

Upon discovering this issue, Ewbank spoke with numerous peers, along with the Indiana State Board of Accounts, and all were in agreement that the next course of action should be to file a motion for declaratory judgment with Dearborn County Circuit Court, so that the judge may make the decision on how to proceed. This is primarily due to the fact that there is no law specific to conservancy districts that address this type of issue.

Ewbank would like to notify all nominees and believes each nominee should be given the opportunity to speak in front of the judge and weigh in on the matter.

Much discussion was had in regards to this matter. Upon the motion of Greg McAdams, seconded by Mike McCabe, it was approved that Ewbank should notify all nominees tomorrow verbally and then follow up with the motion for declaratory judgment so that nominees can read it themselves.
