#### Administrative Issues

The meeting was called to order by Chairman Mike Noel.

The Directors (and others) recited the Pledge of Allegiance.

Upon the motion of Al Abdon, seconded by Randy Tyler, the minutes of the May 16, 2019 executive session were unanimously approved.

Upon the motion of Greg McAdams, seconded by Al Abdon, the minutes of the June 4, 2019 special meeting were unanimously approved.

It was determined that Paul and Barry will meet this fall to look at the property and identify how much of the area the LCD wants to fix and maintain in the future. The recommendation will then be brought to the construction committee for review.

## Superintendent's Report

Park Plaza demolition is ongoing.

Still awaiting USACE final approval on SCADA design. Once approved, the project will be sent out for bid.

US 50 pump station repairs are ongoing.

Flaherty & Collins housing project is continuing to move forward. At this point, LCD is waiting to receive signed property transfer resolutions from the City of Lawrenceburg. Attorney, Richard Butler, is working with City attorneys to obtain easement agreements, as well.

Park cleaning is complete. Now waiting on Andrew Voros to come and apply the product to keep away black mold/residue. Timing is dependent on dry weather.

Regarding the LCD property requested by Bruce Lagory, Paul is going to ask Land Consultants to revise their survey based on Bruce's request and then will have that property appraised.

After last month's meeting, Paul talked with Townsend regarding concerns surrounding parking on LCD property. Townsend chose to leave the property that day instead of paying LCD for use.
